Terms and conditions

- Must be a permanent and legal resident of the Republic of South Africa
- Must be 18 years or older
- Must have a matric certificate
- Must be available to relocate to Bloemfontein
- Have their own mode of transport
- Cannot be engaged in other means of employment
- Contract valid for 3 months
- Chosen candidate(s) must be available to participate, without restriction, for the full duration of the competition and internship period
- OFM may use your personal information submitted on your application to conduct such background checks that may be deemed necessary in their discretion to confirm that you are a suitable candidate to participate in the competition
- OFM may film, record, document and capture the audition to broadcast at their own discretion
- If you are determined as a winner of the competition, you will be requested to, and hereby agree to, enter into a formal written contract of service with OFM, in terms of which you will be appointed as a presenter for OFM. You acknowledge and agree that you will be disqualified from the Competition and will forfeit all prizes, compensation or other rights that may have been inferred in terms of the competition,

if you refuse to enter into the said service agreement subsequent to your announcement as a winner of the competition. OFM may at its discretion select a different winner in case a winner is disqualified as determined herein.
