Spur Celebration Saturdays Terms and Conditions

- 1. To enter the Spur Celebration Saturdays competition, listeners need to send the word "Spur" to WhatsApp number 066 050 6830.
- 2. Then, follow the prompts for the chance to win.
- 3. Listeners need to download the Spur Family app from their smartphone app store to qualify.
- 4. They need to take a screen shot of the app after it has been downloaded and submit it via the same WhatsApp line when requested.
- 5. Once a complete entry has been received (as per the WhatsApp line), the listener will be entered into the draw to win a R1000 Spur voucher.
- 6. Finalists will be chosen according to what has been stipulated by the station, on-air promos and social media posts.
- 7. Any entry that does not follow the given requirements will automatically be disqualified.
- 8. Listeners who enter on multiple stations will only be chosen for one station.
- 9. For listeners who use multiple phone numbers/social media accounts to enter a competition one entry will be chosen as valid.
- **10.** Language stations Listeners will be chosen as finalists and screened to hear if they can speak the language used in that specific radio station before their names are sent through.
- **11. On social media -** tagging Radio Competitions on entries does not give listeners an advantage of being chosen as finalists or to win.
- 12. When chosen as a finalist, listeners will be asked to share their full name, contact details and ID number (this is to ensure that we don't choose the same person multiple times or disqualify listeners because they have the same name and surname).
- 13. A listener who is chosen as a finalist is not given the guarantee of being announced as the winner, because the final decision is made only by the on-air presenters(radio station)/influencer (on other platforms).
- 14. Should a listener be chosen as a finalist, they will need to have their phones close to them before and during the on-air competition moment/winner announcement time. If the station has not called , then please note that you were not selected as the winner.
- 15. Should a listener not be reachable for screening by Radio Competitions/ Radio Station before/during the on-air competition moment or winner announcement time the next listener will be randomly chosen to take their place.
 - Should the winner be selected as a winner in two or more stations (in one competition), due to entering on multiple stations or using different accounts/phone numbers.
 - That winner will only be rewarded once from one station. Their other winnings will be awarded to other listeners during the course of that specific competition.
- 16. Listeners who win should allow a period of a maximum of 6 weeks to receive their prize money.
 - o Prize delivery(hampers) might take up to a maximum period of 8 weeks.
 - o Winners will be updated should there be any unforeseen delays with delivery.
- 17. Listeners who have won will be eligible to enter/win the next competition after a period of 3 months.
 - Station's competition T's and Cs also apply regarding winners who have recently won on any station's competition.
- 18. Should they enter and win before the 3 months is complete, they will forfeit the prize.
- 19. Entering multiple times in one station during a single competition is encouraged.
- 20. The listener will only be chosen once as finalists in a competition. Their details will be included in a list that will be sent to the station, who will then choose the winner from the list.

- 21. The Station/Radio Competitions will call winners for banking/physical address to send their winnings.
- 22. All Radio Competitions platforms shall not be used to discriminate, abuse others or for any fraudulent activity. Should one come across such problems, please kindly contact us via DM, Inbox or email.
- 23. Should anyone be found to have committed the above, they will be blocked from all our online platforms and competitions.
 - Should that listener be chosen as a finalist/announced as the winner in any of the competitions administered by Radio Competitions, due to the use of a different social media account/phone number, they will be automatically disqualified, and the prize will be awarded to another listener.
- 24. Should there be a delay on prizes, listeners are advised to first contact the Radio Competitions social media pages to enquire so that the matter can quickly be resolved.

Request for banking/physical address details.

- Winners will be requested to provide their banking details, where their prize money can be transferred. Should a listener not have a banking account, they can use a friend's or a family member's banking account.
 - Should the winner choose to use a friend's or family member's bank account, they will need to provide proof of account/first page of a banking statement.
- 2. Winners will be requested to send their banking/physical address in writing, via SMS, email or Social media platforms. (This is to avoid capturing the winner's details incorrectly).
- 3. In the event where an extra prize was added for a winner who is a customer or uses a client's product, the proof will be required.
- 4. If having a bank account with the client running the competition is what is required from listeners to win an extra prize
 - Listeners will be asked to share proof of account using an email or via social media message options.
 - Should the winner provide an incorrect banking/physical address, they will be held liable for the loss of their prize.
 - Radio Competitions/Radio stations, any of our partners or those we work on behalf of - will not be held accountable for any loss of prizes.
